#### 12. Evaluation Criteria:

The submitted bids shall be opened on scheduled date & time, by an authorized Opening Committee & the Total Cost quoted by eligible bidders shall be compared. A comparative statement shall be prepared by the Committee & the Bidder who has quoted the least cost (Gross Total of the BOQ) shall be declared as L-1 bidder & may be considered for award of the work.

13. Defect Liability Period/Warranty Period: Defect Liability Period shall begin from the date of asset handover or from the date of installation and repairing of Water Sprout. Warranty of minimum 1 year (12 months) shall be provided against all chiller system. The Contractor shall promptly replace any defective material and not rectify it, and will rectify any workmanship defect in executed work notified by Maha-Metro during DLP, within seven (07) days of notification of defect by Maha-Metro.

## 14. Payment Terms:

a. Payment for Schedule-A will be made after satisfactory execution of rectification work within 30 days and Payment for Schedule-B will be made monthly basis, and after certification by the Engineer in-charge of execution dept. of Maha-Metro.

- b. Payment shall be made within 15 Days from the date of submission of Certified Bill by Execution dept. to Finance dept. of Maha-Metro. However, no interest/compensation shall be paid due to any delay due to unforeseen reasons or whatsoever.
- c. Payment shall be made to the Contractor as per the actual quantity of work executed at site and as per schedule in Annexure-A.
- d. Payment shall be made to the Contractor in INR only, and through electronic means: RTGS, NEFT or Net banking only.
- e. Maha-Metro shall deduct the tax at source (TDS) from the payments to the Contractor which Employer will be required by law for deposition with the statutory authorities in India for which TDS certificates will be issued by Maha-Metro.
- f. The payment of all applicable taxes & duties including GST and any other charges shall be in scope of the Contractor and the quoted price shall be inclusive of these taxes & duties. The Contractor shall provide break up of taxes and duties in its invoices. Any variation in statutory taxes and duties will be borne both ways i.e. in case of increase in taxes and duties, Maha-Metro will bear the additional amount and in case of decrease in taxes and duties, Maha-Metro will be reimbursed the difference amount.

#### 15. Liquidated Damages (LD)

The work shall be strictly completed as per the timeline given above. LD shall be imposed at a rate of 0.1% of the accepted LOA/Work Order amount for each day of delay after the completion period subject to a maximum of 10% of accepted LOA/work order amount.

## 16. Penalty

In case the execution of work is not found to be satisfactory, proportionate deduction from Contractor's Bill shall be made and the LOA/Work Order can be terminated by Maha-Metro after giving a Notice of Three (03) days to the Contractor. In case of such termination, the Performance security deposit shall be forfeited by Maha-Metro.

#### 17. Termination:

Maha-Metro reserves the right to terminate this LOA/Work Order at any time without assigning any reasons, after giving a notice of Three (03) days.

**18. Extension of time**: Suitable extension may be granted for delay due to unforeseen reasons, if certified by Maha-Metro.

#### 19. Variation:

a) The LOA/Work Order shall be awarded on fixed rate basis for the entire work period. No request for escalation in rates shall be entertained on account of any reasons during the work period or its further extension due to unforeseen reasons.

### 20. Performance Security Deposit:

Performance Security Deposit @10% of the Accepted LOA/Work order amount shall be deposited by the Contractor through NEFT/RTGS/Internet Banking in the account of Maharashtra Metro Rail Corporation Ltd. within 15 days from the date of issue of LOA/Work order.

The Performance Security Deposit shall be returned by Maha-Metro after expiry of DLP & issuance of Work Completion Certificate by Maha-Metro for satisfactory work execution. In case of breach of any terms and conditions stipulated in the contract, the Performance Security Deposit of the firm/company will be liable to be forfeited by Maha Metro besides annulment of the contract.

## 2. Comprehensive Annual Maintenance:

- 2.1 The agency has to maintain, repair and replacement of purification system, various types filters, storage tank/box, cooling system, compressor, booster pump, display. push button, internal wiring for proper functioning of the machine, etc. and any other miscellaneous items of water cooler cum purifier machine to up keep the system in good working condition.
- 2.2 The agency has to carry out three periodic detailed servicing in a year, which will comprised through checking, cleaning, servicing, any adjustment in machine and replacement of filters requires if any
- 2.3 The agency has to carry out routine monthly visit/ check up at all locations to check the machine working condition and quality of drinking water Agency has to submit monthly report for the same.
- 2.4 Agency has to provide on call service or additional service as and when required on emergency basis to check the machine mall functioning/ breakdown etc. This service is to be provided by agency free of cost.
- 2.5 Agency has to nominate and provide an exclusive highly qualified engineer/technician who will be available on call/emergency service.
- 2.6 The agency has to respond immediately in case of machine breakdown and required to attend the issue on time at site. If any major breakdown like compressor, booster pump, cooling system issue is to be attend/resolve within 48 hours.
- 2.7 Agency has to maintain the water cooler/ purifier in good working condition all the time throughout the duration of the contract period.
- 2.8 Agency has to maintain the log book property by getting sign of concerned engineers from time to time and same shall be attached for billing
- 2.9 Agency has to maintain and submit the monthly work done report duly verified by concern engineer.

The scope work in general includes scope of work specified in the schedule of rates & quantities of the bidding document. Further it includes any other work not specifically mentioned but required to complete the work as per instructions of engineer-in-charge. - Replacement of pre-filter candles, duel filter cartridge or any other type of cartridge if required, as per standards or as per site/ machine requirement. It is to be provided free of cost.
- Replacement of activated carbon granules or activated carbon block or any other type of granules if required, as per standards or as per site/ machine requirement. It is to be provided free of cost.
- 3. It includes all the electrical wiring/ electronic component servicing, replacement and maintenance as and when required. It is to be done free of cost.
- 4. In case of machine breakdown immediate response required to attend the issue on time at site. If any major breakdown like compressor, booster pump, cooling system issue is to be attend/resolve within 48 hours.

The contractor's scope of works will be execution of repair & maintenance works etc. as per the following:

#### A. Routine monthly Inspection:

Checking the machine's working condition, temperature indicator, water outlet nozzles/taps, cleanliness of the bowl mesh/holes, drainage outlet pipe, condition of the push button, booster pump, electrical connections and the quality of drinking water (ie., TDS checking).

#### **B.** Details of Service Inspection:

Three periodic detailed services a year include checking, cleaning, servicing, making any necessary adjustments to the machine, and replacing filters if needed.
