LOA for Stage-II: For Scope of Work under Pricing Summary-II at the cost of INR 279,18,41,186/- will be issued separately at later date.

### 3. Contract Price:

3.1 The accepted Contract Price for Stage-I: For Scope of Work under Pricing Summary-I, amounting to INR 1364,59,18,179/- (Rupees One Thousand Three Hundred Sixty-Four Crores Fifty-Nine Lakhs Eighteen Thousand One Hundred Seventy-Nine only) includes all costs associated with the subject work and any subsequent amendment or revisions thereof as per the Terms & Conditions outlined in the Tender Document. #### 4. Taxes and Duties:

- 4.1 The awarded contract price is including GST & all other applicable Taxes, Duties, Levies, and Royalties etc. as specified in tender documents.
- 4.2 All taxes, duties, levies prior to Base date i.e., 28 days prior to latest date of submission of Bid is deemed to be inclusive in the price quoted by Bidder.



- 4.3 Any change in legislation of any kind of Taxes by GOI or GOM, after Base Date shall be accounted separately and shall be applicable both ways (Reimbursement & Deduction).
- 4.4 TDS towards Income Tax, GST etc. leviable under the applicable laws shall be deducted by Maha-Metro at the time of payment of any amount towards this work. Details of taxes deducted/ Tax deduction certificate at the source shall be issued to Contractor as per standard practices.
- 4.5 The Contractor is required to maintain/furnish Complete records of taxes, duties, levies, etc. payable/ paid by you to various authorities in relation to the services/work and submit receipts along with each interim Bill and final Bill that will be raised by M/s ITD Cementation India Limited. Maha-Metro may require supporting documents for the same.

#### **5. Vitiation:**

In line with ITB 39.1, Section-II: Bid Data Sheet of Part-1: Bidding Procedure, the bidder has to be lowest throughout the Contract period, Vitiation shall come in to effect as soon as the LOA for Stage -1 is awarded (Pricing summary-1). Vitiation shall be checked and settled for each Running Account Bill based on the lowest prices identified in the financial bid of all bidders who participated in this tender.

#### **6. Scope of Work:**

Design and Construction of Underground Stations at Market Yard, Padmavati, Katraj stations & Associated Tunnels in Stage -I and stations at Bibwewadi & Balaji Nagar in Stage -II of Swargate-Katraj Section of Pune Metro Rail Project- Under Ground Extension

The scope of work shall be governed by the details provided in Part-II of the Bid Document and any amendment made thereto issuing Corrigendum prior to the closing of bidding procedure.

#### **7. Commencement, Completion of Work and Defect Liability Period:**

- 7.1 Pursuant to Clause 8.1 of Particular Conditions of Contract, the date for the Commencement of Works for this Contract shall be the date of issue of "Letter of Acceptance" and accordingly this LOA is to be treated as "Notice to Proceed" and therefore you are required to commence the work hereafter considering the date of commencement as date of issue of this LOA.
- 7.2 The Works shall be completed within 42 Months (Forty-Two Months) including defect free completion and have passed the tests on the completion including integrated testing wherever in the scope of work and commissioning whole of the Works and parts thereof before the same is taken over by the Employer, but excluding Defect Liability Period.
- 7.3 Contract Key Dates, corresponding Liquidated Damages and schedule of completion as per Bid Documents & your submission shall be binding upon you. (Ref: Appendix 2-B of Work Requirement, Key Dates and Penalties as amended by Corrigenda, if any).
- 7.4 The Defect Liability (DLP) Period for this work is 24 months from date of taking over as mentioned under clause 1.1.27 of part-A of Part-3 Particular Conditions of Contract.



## **8. Payment Terms:**

- 8.1 Payment Terms shall be in accordance with the clause 14.7 of Section-VIII: General Conditions of Contract read with Section-IX: Particular Conditions of Contract. Interim and final payments shall be governed by the Terms & Conditions set forth in the Tender Document and any amendments made thereto by corrigenda/addenda (if any).
- 8.2 The Contractor is required to submit the Bills/Tax Invoices in the format approved by the Engineer-in-Charge or the Employer. The Bills/Tax Invoices shall specify the amount and proper break up of taxes, duties, etc. against the work executed.

## **9. Advance Payments/Mobilization Advance:**

- (i) The advance payment shall be dealt as per clause 14.2 of Section-IX, Particular Conditions of Contract.
- (ii) Interest bearing Mobilization advance shall be 10% of original contract value payable in two equal installments of 5% (Five Percent) each in the currencies and proportions of the Accepted Contract Amount.
- (iii) Mobilization advance shall be paid against acceptable Bank Guarantee for an amount of 110% of the advance amount issued from a Scheduled Commercial Indian Bank or Schedule Commercial Foreign Bank (Except Cooperative Bank) having business offices in India. The Bank Guarantee shall be valid for 60 Days beyond scheduled completion time. The validity of Advance Bank Guarantee shall be extended as per extended time of contract plus 60 days, if the Advance Amount is not recovered completely. The format of Bank Guarantee for Mobilization Advance is attached as Annexure- II.
- (iv) Advance payment shall be governed in terms of condition of the contract as set forth in tender documents and amended by tender addenda/corrigenda (if any).

## **10. Performance Security:**

## **11. Insurances:**
