- e. Any condition(s) incorporated by bidder other than above, shall result in outright rejection of the offer/ proposal.
- f. Any conditions, deviations, assumptions, exclusions, suggestions of alternative clauses, request of amendments in conditions & specifications of work or any other information submitted by you along with the Quotation Form, which is different from the Quotation Form & Quotation Notice issued by Maha-Metro or its representatives, shall not be treated as a part of the LOA/Work Order and shall not be binding upon Maha-Metro in anyway whatsoever at any stage of work during execution or thereafter, unless specifically agreed to by Maha-Metro in writing.

13. Evaluation Criteria:

The submitted bids shall be opened on scheduled date & time, by an authorized Opening Committee. Bidder having experience of subject work shall be considered for technical evaluation. Bidder shall submit work completion certificates/ any other supporting documents of similar works having experience of 2 years in supply of Automatic Gate flaps from the last date of submission of bid. Work completion certificate/ any other supporting documents for one-year experience (among 2 years as mentioned above) can also be considered for evaluation. The Annexure B must be signed off by bidder as an acceptance of technical specifications. Any deviation from Annexure B will not be accepted. Based on technically qualified bidder & total cost quoted by eligible bidders shall be compared. A comparative statement shall be prepared & the technically eligible bidder who has quoted the least cost (Gross Total of the BOQ) shall be declared as L-1 bidder & may be considered for award of the work.

14. Payment Terms, Key Dates and Work Milestones:

- a. 100% payment on completion of subject work. Payment will be done within 30 days from the date of submission of certified bill by official of Maha-Metro to the Finance department.
- b. No advance payment will be made.
- c. No interest/compensation shall be paid due to any delay due to unforeseen reasons or whatsoever.
- d. Payment shall be made to the bidder in INR only, and through electronic means: RTGS, NEFT or Net banking only.
- e. Maha-Metro shall deduct the tax at source (TDS) from the payments to the Bidder which will be required by law for deposition with the statutory authorities in India for which TDS certificates will be issued by Maha-Metro.
- f. The payment of all applicable taxes & duties excluding GST and any other charges shall be in scope of the bidder and the quoted price shall be inclusive of these taxes & duties. The Bidder shall provide break up of taxes and duties in its invoices. Any variation in statutory taxes and duties will be borne both ways i.e. in case of increase in taxes and duties, Maha-Metro will bear

the additional amount and in case of decrease in taxes and duties, Maha-Metro will be reimbursed the difference amount.

15. Liquidated Damages (LD)

The work shall be strictly completed as per the timeline given above. LD shall be imposed at a rate of 0.2% of the accepted LOA/Work Order amount for each day of delay after the completion period subject to a maximum of 10% of accepted LOA/work order amount.

16. Penalty

In case the execution of work is not found to be satisfactory, proportionate deduction from Bidder's Bill shall be made and the LOA/Work Order can be terminated by Maha-Metro after giving a Notice of Seven (07) days to the Bidder. In case of such termination, the Performance security deposit shall be forfeited by Maha-Metro.

17. Termination:

Maha-Metro reserves the right to terminate the LOA/Work Order at any time without assigning any reasons, after giving a notice of Seven (07) days.

18. Extension of time: Suitable extension may be granted for delay due to unforeseen reasons, if certified by Maha-Metro.

19. Variation:

- a) The LOA/Work Order shall be awarded on fixed rate basis for the entire work period. No request for escalation in rates shall be entertained on account of any reasons during the work period or its further extension due to unforeseen reasons.
- b) The Employer at its discretion, may reduce/delete items as specified in scope of work depending upon requirement & other factors. Any addition in the scope of work shall be payable at the mutually agreed rates & amounts.





- 4. Warranty period: 12 Months from the date of handing over of flaps to the Maha Metro, Pune (Warranty certificate to be provided)
- 5. The flaps of Automatic Gates shall be made with PU- foam with a metal insert inside. The tip of the flap should be soft to absorb any accidental impact that happens on the passenger. If the flap barrier is forced open, no damage shall happen to any of the gate components.

- 6. Flap design should be sturdy to withstand peak hour rush ensuring no possibility of injury to passengers. Also, the flap should be sufficiently durable to withstand impact from passengers without being severely damaged/ affected.
- 7. Flaps should be compatible with the existing Automatic Gates of OEM M/s Magnetic FAAC India Pvt. Ltd. installed in Line-1 and Line-2 stations of Pune Metro Rail Project.
- 8. A sample flap shall be provided by Maha Metro, based on which one demo flap to be provided by the vendor after award of work. This demo flap shall be installed in live/production environment Automatic Gate for performance testing. Accordingly, further clearance shall be given.
- 9. Certification for PU material, internal metal plate or quality certificate or any relevant certificate for AG Flaps to be submitted.




AG - Standard Flap (Purple)
