

HOW TO FILE RTI APPLICATION WITH MAHARASHTRA METRO RAIL CORPORATION LTD. (PUNE METRO RAIL PROJECT)

Any citizen of India who desires to obtain any information under the Right to Information Act, 2005 (Act) may request to Public Information Officer, Maharashtra Metro Rail Corporation Ltd, A2, A3 Block District Court Interchange Metro Station, Nyaymurti Ranade Path, Shivajinagar, Pune - 411005

Application Fee: In accordance to the directive given in the Gazette notification issued by Department of Personnel & Training, Ministry of Personnel, Public Grievances and Pension, Govt. of India, vide no. 34012/8(s)/2005-Estt(B) dated 16.09.2005, the application for obtaining Information under sub-section (1) of section 6 must be accompanied by the prescribed application fee. At present the application fee is as Rs 10/-.

Mode of Payment:

1. By demand draft/banker's cheque / postal order drawn in favour of 'Maharashtra Metro Rail Corporation Limited payable at Pune'.

3. Persons who belong to BPL category are not required to pay any fee provided necessary documents are produced in support of their claim.

Additional Fee: In case additional fees are required, the applicant will be informed about the same.

RTI fee of Rs 10/- can be submitted through Indian Postal Order (IPO) or through Demand Draft (DD) in favour of Maharashtra Metro Rail Corporation Ltd, Pune or by online payment mode "Bank Name: Bank of Maharashtra, Account Name: Maharashtra Metro Rail Corporation Limited, Account No.: 60274237292, IFSC Code: MAHB0000043

The fee (IPO/DD) can be submitted at the office of Public Information Officer (PIO), Maharashtra Metro Rail Corporation Ltd, A2, A3 Block District Court Interchange Metro Station, Nyaymurti Ranade Path, Shivajinagar, Pune – 411005. One can personally deposit the fee (in IPO/DD) at the office of PIO or alternatively he / she may send IPO or DD by post to following address.
